# Thirty-ninth Amendment of the Constitution

## What you should know...!!!

### **This is a Bill entitled, an Act to amend the Irish Constitution**

This provision, provides a universally applicable right to housing and, accordingly, shall delimit the right to private property in order to ensure the 'common good'.

**This Bill also seeks to delimit the protections given to private property owners** in favour of the common good, which does allow, even under our Constitution, for the Government to override private property rights.

## SCHEDULE PART 2, Section 3.1

The State, in particular, recognises the common good as including the right to secure, affordable, dignified housing, appropriate to need, for all the residents of Ireland and shall guarantee this right through its laws, policies and the prioritisation of resources.

- Who gets to define the 'common good' and what is in the homeowners' best interests?
  - E.g, "you've got a large home there, do you really need to live in a 2-storey 4-bedroom house for 2 people with all that space?"
- This law, if passed, could potentially allow the government to relocate homeowners to a property appropriate to need
- What does 'dignified housing' mean?
- 'Appropriate to need'
  - The needs of whom?
- 'Residents of Ireland'
  - Not citizens, therefore anyone living here will be entitled to a home
- 'Prioritisation of resources'
  - Whose resources?

## SCHEDULE PART 2, Section 3.2

The State, accordingly, shall delimit the right to private property where it is necessary to ensure the common good and to vindicate the said right to housing for all residents of Ireland.

- 'delimit' – very concerning word.
  - it has the potential for restrictions of people's private property rights
  - could this also mean land seizures?
- This Bill has the potential for confiscation of private property and to be repurposed for the 'common good'
- This is a Right to Housing Bill, not a Bill for the right to owning your own private home
- A right to housing means that a person, just has the right to be housed somewhere. It doesn't mean they will have the right to own their own house
- The Irish Constitution was always there to protect us, but this Bill will give powers to delimit the right to private property
