

5. COST OF LIVING CRISIS

- ❖ Fuel is 52% tax; the govt. could reduce this if they wished.
- ❖ ESB is 95% govt owned and increased profits to €679 million in 2021.
- ❖ Govt have raised their own salaries multiple times since 2019.
- ❖ 2022 has a record overall poverty rate; increased from 13.3 % to 19 %.
- ❖ BlackRock and Vanguard could own almost everything by 2028 giving *them* monopoly on prices and *us* no choices, resist now while you can.

What can you do:

- * Keep money in the local area. Buy local and from independent shops not global corporations.
- * Refuse to use automated systems and machines that replace people (checkouts etc).
- * Refuse to install a smart meter, it will be used to charge extra at peak hours.
- * Join any campaign to oppose rising prices.
- * Do not comply with further lockdowns/restrictions (in the name of climate change perhaps) keep your business open, keep the economy going. Communities have been destroyed economically, socially and mentally do not let it happen again.



The govt. has led us to believe that the cost-of-living crisis is caused by the war in Ukraine whereas it is really a cost of lockdown, govt. greed and inflation crisis.

1. CASH IS KING

What Can You Do:

Use cash as much as possible & spread the word. Refuse to use businesses that don't take cash (tell them why). By law you can't be refused service, or a product for cash as it is legal tender!

Benefits of Cash

- ❖ Cash flowing saves money for small businesses and keeps local banks open.
- ❖ It benefits tradespeople, gardeners, cleaners, childminders, waiters, traders (crafts, festival, food) tutors, homeless people, those saving to escape abuse.
- ❖ You cannot be tracked; or cut off from your own money if the government doesn't like your behaviour (this is happening in Canada, China, Australia).
- ❖ In a cashless society the government can dictate what kind of food you can buy and the quantity of meat, alcohol, fuel etc that you are allowed.
- ❖ Cash keeps you safer from fraud, you can take your money out of the bank if you fear a crash, and you don't need expensive software and devices.

2. DIGITAL ID & SOCIAL CREDIT SYSTEM

What Can You Do: Use Cash & refuse to accept a Digital ID.

A European Digital ID is on the way (announced in 2020). All your personal documents will be on it and it will be used for accessing public services, bank account, paying taxes, etc. It is already mandatory in Ukraine (Diya app) and Latvia (eID) and has been introduced in France.

Social Credit System

What Can You Do: Refuse to Accept/Use It.

A DIGITAL ID is needed for this points-based system (assessed by artificial intelligence). You are penalised for high carbon footprint, disagreeing with the government, delay in bill payment, too much socialising/fast food/alcohol etc. Penalties include bank loan/credit card refusal, limited access to public transport/cinemas/shops/good schools.

Social Credit systems are already in place in Europe and the USA and could eventually be mandatory. The vaccine passport was a type of social credit system. China, where people already live under this system, is a dystopian nightmare.

3. WHO PANDEMIC TREATY

What Can You Do: Contact your TDs and the Attorney-general (see website).

The World Health Organisation (WHO) want 194 countries including Ireland to sign a legally binding Agreement that will give the WHO control in any “public health emergency of international concern”. This would destroy Irish sovereignty.

Stephen Donnelly has said he will sign the WHO treaty which will take precedence over the Constitution of Ireland SUSPENDING as a MATTER OF LAW Articles 6 (1) and (2) in the event of a ‘public health emergency’. **The terms provide for a takeover not only for medical situations but also for climate change.**

The WHO is an unelected body mostly funded by private corporations pushing their own agenda for profit. As previously the WHO will push lockdowns, vaccinations and closure of businesses and social services; causing countless mental, physical and economic suffering. They could also dictate agricultural/food policy.

4. AMENDMENT 39 and THE HOMELESS CRISIS

The Irish govt. caused the homelessness & housing crisis by the following policies.

- ❖ Giving incentives to multinational corporations to buy up Irish homes (causing increased rents and raised house prices). 95% of apartments were sold to investment companies in 2019. ‘Vulture funds’ have been banned in other countries.
- ❖ Giving public land to private developers and making it impossible for local authorities to build.
- ❖ Not providing social housing at cost price.
- ❖ Not dealing with rent control and unfair evictions.
- ❖ Not building public and affordable housing on govt. owned land (NAMA have enough land to build 80,000 affordable houses but are building and selling units at maximum profit, fuelling rising prices).



Q: why have successive Governments not built sufficient affordable housing.

A: It does NOT serve the interests of international financial corporations.

THIRTY- NINTH AMENDMENT OF THE CONSTITUTION

If passed this will ‘delimit’ people’s private property rights (confiscation/compulsory purchase of homes, land etc) for the ‘**common good**’ (decided by the state) to provide housing for ‘**Residents of Ireland**’ (not citizens, so anyone living here).

*A right to adequate housing is already established in international law, other countries have legislated for housing while keeping the right to private property.
Leave Our Constitution Alone*

This is a Right to Housing bill, it only gives you the right to be housed somewhere *not* the right to own your own property. It will ensure that Irish homes are owned by global financial corporations not by Irish people The property of ordinary citizens in Ireland could be seized but as we all know, the State will not seize the property of the multibillionaire foreign investors.
