## **Two Major Threats to Our Future**

# No 1: The W.H.O. GLOBAL PANDEMIC TREATY which will SUPERCEDE the IRISH CONSTITUTION if passed.

This is the boldest move ever to take away Irish Freedom; many died for our sovereign rights, we need to protect them, now and for our children.

The World Health Organisation (WHO) are asking 194 countries to sign a legally binding Agreement that will give the WHO control in any "public health emergency of international concern". In Ireland this would SUSPEND as a MATTER OF LAW Articles 6 (1) and (2) of THE IRISH CONSTITUTION.

#### What Will This Mean?

- Future governments in 194 countries including Ireland will have no say as the WHO can take over if they decide there is a 'health emergency' Sanctions for those who don't comply.
- The *One Health Policy* includes the health of humans, animals and the planet so many things could justify 'a health emergency'. The WHO could dictate not only medical but also agricultural, food and fuel policy.
- Future lockdowns, closed businesses/social services, major changes to how we live, mandatory vaccinations - without our consent.
- Pharma companies and multinationals profit, small businesses close, ordinary people suffer (pharma doubled their profits in 2021).

#### Who are the WHO?

A politically appointed unelected body (so we the people have no say). 80% of their funding is private or voluntary, much of it from pharma companies that we can't trust (google Pfizer's criminal record, it's a long list).

#### No 2: New DIGITAL IDs

(All could be amalgamated into one in the near future)

a) **EU Vaccine Passport** - came into effect 1 July 2021, temporarily not being used in Ireland, still in use in several countries.

b) **WHO Global Vaccine Passport**. The WHO announced in February 2022 that they are introducing this, it will replace the EU vaccine passport. Everyone will be linked to a QR Code (initially for Covid 19 vaccines; it will later include other vaccinations & "digital health initiatives").

c) **European Digital ID** (announced in 2020 and currently moving ahead). All personal documents including your passport will be on your ID. It will be used for accessing public services, bank account, paying taxes, etc (initially voluntary it is likely to become mandatory).

CONCERNS: security, control, surveillance, sanctions.

#### WHO Treaty & Digital IDs What will this mean?

- Absolute power over you. Total surveillance. Sanctions for people who don't comply.
- Cash will be phased out.
- No place for those who like a digital-lite life.
- Peaceful protest will no longer be possible due to sanctions. (Canada recently froze peoples bank accounts for donations to a peaceful protest)
- Frequent covid vaccines, this will be expanded to include other vaccines/medicines. Even more profit for Pharma.
