This will mean big industrial farms, or not using land for food so that people will have to buy lab-made meat/milk/eggs and factory grown food. Bill Gates while building factories to make lab-made meat/eggs/milk has bought a quarter of a million acres (the biggest USA farmland owner).

The Irish government instead of standing by farmers are pushing the agenda of multi-national corporations, all of whom use their fake 'Green Agenda' for profit, this is clear because our government continually ignore creative ecological solutions offered by scientists and farmers.

Food production is our most vital use of land. Land regeneration, creative farming and small biodiverse farms are the way forward, this is not being facilitated and those who go down that road face a ton of red tape.

The United Nations, The World Economic Forum, Food & Farmers
